CA MATTERS - Columbia Council Report

In the midst of the pandemic, the Columbia Association is dealing with a variety of issues that could change CA going forward. Though the CA lien income remains steady, it represents only half of the funds necessary to run this complex organization. The remainder comes principally from facility operations and programs. New statewide covid-related restrictions limit indoor facility operation to 50%. CA has adopted this limit since reopening last spring while instituting many other safety measures to protect users. Predictably, income is down.



February. Staff will present its proposed budget in early January which will be reviewed by the Board and voted on in late February. A virtual town hall is scheduled for January 21 and will likely find the proposed budget to be the central topic. Please join if you have any comments or concerns. Event details will be available shortly.

The Inner Arbor Trust has completed a new concept plan for Symphony Woods and presented it to the Board. The Trust began a very collaborative process with a group of experts, a committee of residents representing major stockholders such as CA, the DCACC, County Rec and Parks, Howard Hughes, and members from a variety of arts and community organizations. The plan, presented to CA last month, recognizes the changes in use and development of the Park and the surrounding area. It has reimaged major components, added entrances from all sides of its 51 acres, incorporated woods and streams previously ignored into a signature place for arts and culture, recreation, and contemplation.
